Imphal, the 19th August, 1995

No. 46/1/79-ED (v) (VIII) Kalkho-en Academy, Suangdoh under the Zonal Education Officer, Churachandpur having classes Nursery to VIII is found to have fulfilled the following prescribed conditions:

- a) Recommendation of the Zonal Education Officer concerned for its provisional recognition.
- b) Deposit of Rs.1000/- (Rupees One thousand) only as recognition fee in the Government Account under Challan No. 3 dated 4-08-1995 of the U.B.I., Churachandpur Branch.

The Department, therefore, accords sanction to the recognition of the School on the following conditions:-

1. Recognition is accorded provisionally for a period of 1 (one) year with immediate effect and the same may be withdrawn provided the management of the School is found unsatisfactory.
2. The School authority should seek from the Department for further extension of recognition after the expiry of one year with a report on the management and strength of students of the school from the Zonal Education Officer's concern.
3. No higher classes in addition to the existing classes in the School should be opened without prior permission of the Department.
4. No financial grant/assistance should be sought by the School authority from the Department after recognition of their School.
5. The School should follow the prescribed Text Books and syllabus of the Government of Manipur failing which recognition may be withdrawn.

It is further ordered that no financial Grant-in aid and additional post shall be accorded as per Order dated 18-8-98 of the Hon'ble High Court passed in C.R.No.145/98.
